

Planning to **travel with Evrysdi?**

Here are some **tips that can help**



Getting **ready**

- 1** **For air travel,** Evrysdi comes packaged in liquid form (60 mg/80 mL), which is permitted by TSA to keep in your carry on bags and go through the x-ray machine without exceeding the 3.4 oz liquid limit.
 - Remember to bring any relevant identification with you when traveling, such as any declarations of medical need you may have from your healthcare professional for any of your medicines in the event you are stopped while checking in
 - Find additional travel considerations on the back page
- 2** **Call ahead to the hotel** or where you are staying to ensure your room has a working refrigerator to store your medicine.
- 3** **Make sure you have your Evrysdi travel cooler** and you're familiar with the storage requirements:
 - Always store Evrysdi upright in the refrigerator (36°F to 46°F) in the original amber bottle to protect it from light. Do not freeze Evrysdi or put the medicine in a different container
 - Evrysdi should be refrigerated between 36°F and 46°F for up to 64 days
 - If refrigeration is not available, Evrysdi can be kept at room temperature up to 104°F for a combined total of 5 days. It can be removed from, and returned to, a refrigerator. The total combined time out of refrigeration should not exceed 5 days
 - Ask your pharmacist for the Discard After date if it is not written on the bottle label
 - Any portion of Evrysdi that has been kept above 104°F should be discarded
 - Always store your medication in a safe place out of the reach of children

Important **considerations**

- ✓ If you'll be away from home for an extended period, **you may need additional medication.** Contact your Specialty Pharmacy to make the necessary arrangements.
- ✓ If you're traveling internationally, it can be helpful to check in with the US embassy in the foreign country you will be visiting before your departure.
- ✓ You may want to purchase a thermometer to ensure your medicine is stored correctly. Some thermometers can even send alerts to your phone!
